### CONDITIONS

- Above prices are based upon start and end at Frederiksdal (Furesøen) and Sorgenfrivej (Lyngby Lake/Bagsværd Lake). If you wish to start and/or end at another stop there will be a fee between DKK 250—DKK 750 each way
- The prices above include a captain and a host
- Note that “Monday price” applies for days without regular sailing schedule. See schedules on [baadfarten.dk](http://baadfarten.dk)
- From 7 pm until sunset, an additional fee of DKK 500 per hour will be added
- The boats may not operate off-season nor after sunset
- Minimum rental period is 1 hour. One hour boat rental is ca. 50 minutes of sailing
- Confirmed orders can be cancelled free of charge until four weeks prior to departure at the latest

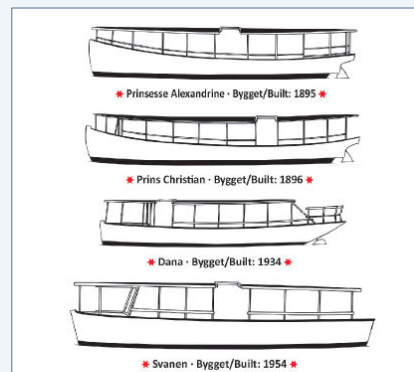
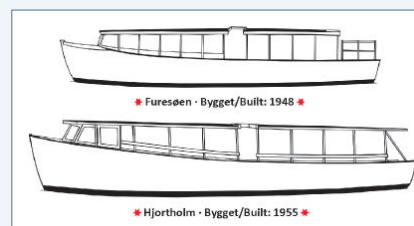
